II. Discussion on CBT Projects:

NMSA has secured two grants from the Chesapeake Bay Trust (CBT) totaling \$350,000. The grants terminate April and September of 2020 respectively. The two grants operate as one funding package for the purpose of completing the work. NMSA has requested and received a 6-month time extension, reflected in the above indicated termination dates. NMSA previously contracted with Storm and Stream, LLC to assist in completing the work. The projects to be completed under the grants are:

- Ag/Stormwater Digital solutions. This work is being completed by a subconsultant to Storm and Stream – Coefficient, located in Washington DC.
- Pond Summit
 - o Two events (meetings), one in MN, one in the Chesapeake Bay Watershed
 - o Research and practitioners to participate
 - o Zach Henderson noted that nutrient export should be covered.
 - o The events will also be web/cast or livestreamed.
- Gl Certificate



- The prototype course will be provided by the University of Massachusetts Eastern Shore. The course will be held in the Spring of 2020.
- Seth Brown to follow up with Pat Sauer (IA) to consider options for holding the course through IA institutions.
- NMSA members are encouraged to help serve as instructors for the courses.
- o Format is 5 7-minute videos assembled into a course module
- Web platform will be EdEx.
- Other potential venues to off the Courses: UDC, Parkland College and George Mason.

Smart Green Corridor

- Target younger staff / professional staff
- Work will demonstrate GI implementation along urban corridors
- o Follow up w Adriana Calderelli re: award at WEF Symposium
- Brian Currier and Pat Sauer are interested in assisting on this project.

• Online Resource

- Develop a brief abstract for WEF Symposium as a presentation
- This project will provide resources for Phase II MS4s to assist in implementing their stormwater program.

III. USEPA Engagement

- NMSA will hold meetings with USEPA staff in January as well as April

- Current topics for discussion include TMDLs, public education and outreach, funding and financing and source control.

- Brian Currier What is the threshold for requiring multiple bids for contracts, etc? (Ans. Scott \$50K, which is consistent with Federal policies, but most grants require bids for any level of funding. Difference is how much advertising is required)
